



Terms of Agreement

1. Quest staff are authorized to administer first aid treatment as and when necessary or to transfer the child to a medical or dental centre for treatment according to the severity of any injury or illness. Treatment may include, but not limited to, hospitalization, visit with a physician, surgery or administration of medicine.

2. Such treatment will be covered by Quest's accident insurance policy. If treatment costs exceed the maximum limit of Quest's policy, parents or guardians will be contacted immediately and they will be responsible for any extra costs. Please contact us directly for a copy of our insurance policy.

3. Children are advised to bring only a limited amount of spending money with them. Any spending money will be kept in a safe deposit box in the Quest offices. All passports and travel documents will be collected on arrival for storage also. While all care will be taken to ensure the safekeeping of these items, Quest and Laguna Excursions Limited will not be held responsible for any loss, destruction or theft.

4. Any photos or videos taken during the camp may be used by Quest in any way including, but not limited to, advertising, display, education, exhibition or editorial use in print or digital form.

5. Both parent and camp participant understand and accept that good behaviour is necessary for the wellbeing of all children and staff. Quest reserves the right to exclude individuals from certain activities or excursions if staff feel that they are a danger or distraction to the group. In extreme cases, parents will be contacted and the child sent home. Use of illegal drugs, tobacco, alcohol, sexual activity, theft, fighting, or disregarding instructions are strictly prohibited and may result in early dismissal of the student with no refund. If a child leaves the camp early for whatever reason, no refund will be available.

6. The camp participant and parent have both read and understood these Terms of Agreement and agree to fully abide by them.

I certify that my child or the child in my care is of sufficient good health to participate in this camp. This camp is conducted by Laguna Excursions Limited, operating as Quest. The scheduled program may change without notice depending on the number of participants and weather conditions. At all times the staff will ensure your children are fully supervised. By signing this document, I understand and accept the Terms of Agreement listed above and agree to adhere to the guidelines set out in the Camp Handbook.
